

The following terms and conditions (the "Terms of Use") shall apply to your use of the websites www.leaseweb.com, secure.leaseweb.com and the Leaseweb Customer Portals (together the "Websites") including any content and functionality offered on the Websites and regardless of whether you gain access to the Websites through the above URLs or any other URL that resolves to the Websites. In addition, these Terms of use shall apply to your use of the Leaseweb API (as defined below). The Websites and the Leaseweb API are operated and made available to you by Leaseweb Global B.V. ("Leaseweb Global"), a private company with limited liability, incorporated under the laws of the Netherlands, with its registered seat at Amsterdam, the Netherlands, registered with the Dutch Trade Register of the Chamber of Commerce under number 60593652. General conditions used or applied by you shall not be applicable to your use of the Websites and/or the Leaseweb API, unless expressly stipulated otherwise in an agreement and agreed upon in writing by Leaseweb Global.

## **CHAPTER A. WEBSITE**

- 1.1. Website Passwords/Usernames. Access to and use of certain areas of the Websites are restricted to authorized users only. You are responsible for maintaining the confidentiality of the password and account. All consequences and losses relating to the use of your password and account, whether or not you have authorized that use, shall be for your sole account, including all placed orders and communication conducted with Leaseweb or its affiliates. You agree to immediately notify Leaseweb if your password is lost, stolen, disclosed to an unauthorized third party, or otherwise may have been compromised.
- 1. Licence. If Leaseweb Global grants you access to password restricted areas of the Websites, Leaseweb Global grants you a non-exclusive, non-transferable, non-assignable, non-sublicensable and royalty free right to use these areas. Said licence shall be limited to (i) viewing the information and performance data, and (ii) using the features included in these areas for the ordinary course of your business. You shall observe each and any instruction of Leaseweb Global regarding the use of said restricted areas of the Websites. ## **CHAPTER B. LEASEWEB API**

- 7. **Token.** To use the Leaseweb Self Service API (the "Leaseweb API"), you must first sign up for a developer account in the Self Service Center. Leaseweb Global will provide passkey(s) (the "Token(s)") upon successfully signing up. You are responsible for maintaining the confidentiality of the Token(s). All consequences and losses relating to the use of your token, whether or not you have authorized that use, shall be for your account, including all placed orders and communication conducted with Leaseweb Global or its affiliates. You must immediately notify Leaseweb Global if your Token is lost, stolen, disclosed to an unauthorized third party, or otherwise may have been compromised.
- 8. **Licence.** Leaseweb Global grants you a non-exclusive, non-transferable, non-assignable, non-sublicensable and royalty free right to use the Leaseweb API to develop, test, and support software (the "API Client Application") that can access or communicate with Leaseweb Global's affiliate's servers through the Leaseweb API, and to let your customers use your integration of the Leaseweb API within your API Client Application. Leaseweb Global reserves the right to suspend or revoke, in its sole discretion, this license and to prevent you from using all or any portion of the Leaseweb API without liability on the part of Leaseweb Global if (i) you act in violation of any of these Terms of Use, or (ii) if any of the Leaseweb affiliates with whom you have entered into a Sales Contract with for the provision of goods or services notifies Leaseweb Global that it has suspended the provision of goods or services under such Sales Contract or that such Sales Contract has been terminated.
- Unauthorized Access to Website. You agree not to access or use the Leaseweb API in any manner that could damage, disable, overburden, or impair Leaseweb Global's computer systems or networks.
- 10. Non-use of Token. Leaseweb Global may terminate or suspend your Token if it is not used for 3 consecutive calendar months.
- 11. **Discontinuance.** Leaseweb Global reserves the right to discontinue the Leaseweb API or any portion or feature thereof for any or no reason and at any time without liability to you. Upon any discontinuance, you must immediately stop and thereafter desist from using the Leaseweb API.

- Security. Each API Client Application must have adequate protections in order to keep secure and prevent the interception of Tokens or other data communicated through the Leaseweb API.
- 13. **Modifications.** Leaseweb Global reserves the right to release modified versions of the Leaseweb API and to require you to use the most recent version. If a modification is unacceptable to you, you must remove the implementation of the API from the API Client Application and discontinue use of the Token.
- 14. **Responsibility.** You are fully responsible for (a) the platforms and operating systems on which your API Client Application is distributed and used, (b) the information, data or instruction sent by the API Client Application through the Leaseweb API, (c) the development of the API Client Application, and (d) the users of your API Client Application. Leaseweb Global has no obligation to provide support to users for your API Client Application.
- 15. **Indemnity.** You will indemnify, defend and hold Leaseweb Global and its affiliates harmless from any third party claim (including reasonable attorneys' fees) relating to (i) any allegation that the API Client Application or the use thereof infringes the intellectual property rights of any third party; (ii) your breach of these Terms of Use.

## **CHAPTER C. GENERAL**

- 16. Changes to Terms of Use. Leaseweb Global may revise and update these Terms of Use from time to time at its sole discretion. Leaseweb Global encourages you to check this page from time to time to take notice of any changes Leaseweb Global has made. Your continued use of the Websites and Leaseweb API following the posting of revised Terms of Use means that you accept and agree to the changes.
- 17. Leaseweb Products and Services. These Terms of Use shall only govern your access to and use of the content and functionality offered by the Websites and the Leaseweb API. You may order goods and services through the Websites or the Leaseweb API from Leaseweb affiliates (including Leaseweb Netherlands B.V., Leaseweb Deutschland GmbH, Leaseweb UK Limited, Leaseweb CDN B.V., Leaseweb Asia Pacific PTE.
